



## THE GUN RIGHTS MOVEMENT IS NOT VIOLENT

**Neither violence nor advocacy through Intimidation are condoned by leaders in the Gun Rights Movement.**

On the eve of a Presidential inauguration that will take place behind unprecedented security after our Nation's Capitol Building was attacked by a small band of violent and destructive rioters, we feel it is important to make this clear.

Since the incursion that temporarily interrupted the certification of the Presidential Election on January 6th, some journalists, media pundits, anti-gun activists and even a small number of elected officials have attempted to tie the Gun Rights Movement to the reprehensible acts that lead to deaths that day and fear of further violence this week. These claims are unfounded.

### **No gun rights organization or recognized leader called for violence on January 6th.**

Political Violence goes against the heart of the gun rights movement. The Second Amendment protects gun rights in order to provide for defense. The gun community has denounced violence tied to protests throughout 2020, as we also condemn the violence and destruction of property at the US Capitol in January 6th without equivocation. As early as the afternoon of January 6th, the President of the Second Amendment Institute International, Tyler Yzaguirre, who lives in Washington, DC, posted publicly: "Today there was an illegal and unprecedented charge on the U.S. Capitol. You have the right to "peacefully" protest. Not to put the lives of members, police officers, and your fellow Americans in danger."

Second Amendment Organization's Executive Vice President, Rob Pincus, has vehemently denounced the violence and posted early during the gathering at the Capitol: "I'm sincerely hoping that this protest remains peacefully disruptive."

Alan Gottlieb, Founder of the Second Amendment Foundation, stated that the small band becoming violent at the US Capitol "...disturbed me greatly."

The list of gun rights movement leaders who have shared similar thoughts is extensive. There are an estimated 100 Million Gun Owners in the United States with over 400 Million Guns. Less than 1000 rioters entered the US Capitol and not one of them fired a single shot. As David Yamane, a Professor at Wake Forest who studies Gun Culture, observed in his rebuke of a recent article in The Atlantic attacking our movement: "As easy as domestic terrorism is to commit, few gun owners turn to insurrectionist violence."

It should also be noted that there is only one political cause that unites all gun owners: Gun Rights. No action being undertaken that day at the Capitol was specifically related to gun rights. The violent mob were only a very small percentage of the people gathered in DC for political purposes that day. They were certainly not us.

Members of every political party and position are Gun Owners in the US. Organizations in our community represent gun owners of various faiths, lifestyles, races and interests. Every State has a gun rights organization representing its residents, most have several. The Second Amendment protects the rights of all Americans, regardless of political party, vote or position on any issue... and we respect everyone's right to hold differing opinions and express them peacefully. At this time of great division in our country, we call for unity amongst all gun owners in the fight to protect our gun rights in the future, regardless of who you voted for or how you feel about the 2020 Election.

A crowd of thousands of US Gun Owners gathered on the west lawn of the US Capitol Building just 14 months ago to Peacefully Rally in Defense of Gun Rights.

A Statement this week from the **2A Rally** group, which held a peaceful 4 hour event at the US Capitol in 2019, by working with the US Capitol Police Special Events Division, included the following:

"Responsible Gun Owners know that violence is an act of last resort, not to be engaged in out of anger or frustration.

*All Gun Owners should consider how their actions might negatively affect our movement. Anyone who feels compelled to protest over the course of the next week should take advantage of their First Amendment Rights lawfully and respectfully. We believe that peaceful protest should be focused on demonstrating strong support for a cause and educational advocacy, not intimidation, towards those one hopes to influence."*

## LIBERTY NOTES

It is a Good Day for Liberty.

The NRA has filed for bankruptcy. This is not as bad as it sounds, but it could be a great deal better to make me happy. The filing in Texas has no doubt delighted the usual suspects. The NRA says that it does not mean that the NRA is bankrupt. Of course, that is what it seems to mean and I would not have phrased it like that. The NRA has filed a Chapter 11 Bankruptcy in the Federal Bankruptcy Court in Texas (see how that word keeps popping up). A Chapter 11 filing seeks to reorganize the filing party with the goal of its continued existence. A Chapter 11 is often used by businesses and cities in order to protect the entity from lawsuits, creditors and to establish an orderly structure to pay everyone off. The creditors may be delayed in getting all their money. The NRA says that everyone will be paid. This may stave off some lawsuits. Legal bills have been an enormous cost to the NRA. The NRA plans to relocate and reincorporate in Texas. I do not think this will stop the persecution by the New York Attorney General. The acts complained of occurred while the organization was incorporated in New York. The NRA current headquarters is in Fairfax Virginia, a suburb of Washington DC. The NRA has filed bankruptcy in Texas because a subsidiary filed for bankruptcy there nearly two months ago. Since the NRA intends to relocate there it makes sense as a friendlier environment. I recall some thirty years ago or more the NRA considered moving to New Mexico. It did not because of the need to have a presence in the DC area. It will continue to need a presence there, but this could be accomplished by the Institute for Legislative Action or a portion thereof.

Some WW II pineapple grenades were sold at the Fancy Flea Antique Mall in Shallotte North Carolina in June of 2020. It was later proved that they were live and a Virginia teenager was killed. The ATF is looking for any other grenades sold at this shop. Military personnel are notorious for bringing back unexploded ordinance. A former MP told me of a nurse who showed up at his desk in Viet Nam with an 82mm mortar shell. The VC had fired it through the roof of her hospital. It failed to explode and she wanted to send it home. The MP told her to take it out back, drop it into the pit for that purpose and, if she lived, come back and see him. Twenty years ago a collector acquired a shell fired during the Civil War. He enthusiastically began to clean the rust off the relic. Then it exploded. In my youth the Kansas City Police sent a team to schools to warn about old explosives and unattended, seemingly broken, guns. The grenades I have seen that have been deactivated have a large hole in the base. Best not to take chances.

In other disasters, I have been diagnosed with diabetes. I have never used alcohol and I gave up sweets when I saw my father's diabetes needles. Still, I get diabetes. Life is not fair. This forces me to read the ingredients on packages of food to check for sugar, carbohydrates and salt; the things that make food worth eating. We had a distinguished member with diabetes who did not watch his diet and lost half his leg as a result. He did not take the hint and died badly. I have no desire to follow him. Still, I wonder, if someone comes after me with a glazed doughnut, is it attempted murder?

Under extreme stress, like a gunfight, adrenaline pounds through the system. Adrenaline eats blood sugar. When a diabetic's blood sugar drops like a rock, he appears to be drunk. The witnesses first statement will refer to "The drunk with the gun." Diabetics need to keep a piece of hard candy in their self-defense gear.

The Kansas City Star quoted an anti-gun rights leader as saying that Missouri has weak gun laws; no background check and domestic abusers can have guns. This is a lie. Federal law requires a background check in gun shops and prohibits persons convicted of even misdemeanor domestic abuse from possessing guns for the rest of their lives. They offer no contrary opinion. I offered to give them information on the law when they began their "gun violence" series, they have not responded.

The same article refers to "Moms Demand Action" as a "gun safety not for profit." The NRA is a gun safety not for profit. Moms Demand Action is an anti-gun rights action group and cannot point to a single gun safety class it has conducted.

The newspapers carry warnings of armed demonstrations planned against state capitals. None of the gun rights groups know anything of such demonstrations. There may be persons with deep, dark and very private plans. The Virginia grassroots has conducted their annual demonstration, but there was no violence and not even a threat. The reports make us seem very dangerous and needing restrictions. The reports of the riot in the Capital Building increase and each report describes them as more organized and a greater threat. Democratic congresspersons claim to have seen republican congresspersons give "reconnaissance" tours to rioters the day before the riot. This is nonsense, the republicans were in as great a danger as the democrats. Greater lies will probably be seen. That riot will be used against us and used to excuse any number of restrictions. This teaches us not to threaten but to show how great a group of friends we can be.

If the time comes to waive guns in people's faces, I will overcome arthritis and do so. But it will be with the knowledge that I have failed.

In the words of two great time travelers, "Be excellent to each other!"  
We shall overcome.

### National Rifle Association Files for Bankruptcy, Plans to Leave New York for Texas

The National Rifle Association announced Friday that it has filed for bankruptcy and will move out of New York and restructure the organization as a nonprofit in Texas.

The nation's leading gun rights advocacy group said that the move to Texas will enable the group to "exit what it believes is a corrupt political and regulatory environment in New York."

"By exiting New York, where the NRA has been incorporated for approximately 150 years, the NRA abandons a state where elected officials have weaponized the legal and regulatory powers they wield to penalize the Association and its members for purely political purposes," the NRA said in a statement.

New York Attorney General Letitia James filed a lawsuit seeking to dissolve the NRA in August, alleging that senior leaders of the group misused tens of millions of dollars, diverting the funds for personal use and other illegal purposes.

The NRA denied the allegations and filed a lawsuit of its own against James, accusing her of violating the group's free speech rights and requesting that her investigation be blocked. The move to Texas and restructuring of the group could prevent the New York attorney general from seeking the dissolution of the group.

The group filed Chapter 11 petitions in U.S. Bankruptcy Court in Dallas, listing assets and liabilities of \$100 million to \$500 million.

However, the NRA insists that the move and reincorporation of the non-profit "comes at a time when the NRA is in its strongest financial condition in years."

The group said there would be no immediate changes to its operations or workforce and promised to "continue with the forward advancement of the enterprise – confronting anti-Second Amendment activities, promoting firearm safety and training, and advancing public programs across the United States."

## Kansas: Permit Recognition Legislation to be Considered on Wednesday

On Wednesday, January 27, the House Committee on Federal and State Affairs is scheduled to consider permit recognition legislation, House Bill 2059.

**House Bill 2059** seeks to recognize all out-of-state concealed carry permits and allow those who have been licensed to carry a firearm for self-defense to do so lawfully in Kansas. HB 2059 also allows individuals who are 18 to 20 years of age to apply for a Kansas concealed carry permit.

### Washington: Vague Carry Ban and Rehashed Mag Ban Introduced and Scheduled for Hearings

Anti-gun legislation, Senate Bill 5078 and Senate Bill 5038, are scheduled for hearings in the Senate Law and Justice Committee. New year, same old tired attempts to further wring your right to self-defense away from you.

On Monday, January 25, the committee will consider Senate Bill 5078, a measure that will ban the manufacture, possession, sale, transfer, etc. of magazines that "are capable of holding" or hold more than ten rounds of ammunition. This includes conversion kits or parts from which any such magazine may be assembled. These so called "high capacity" magazines are in fact standard equipment for commonly-owned firearms that many Americans legally and effectively use for an entire range of legitimate purposes, such as self-defense or competition. Those who own non-compliant magazines prior to the ban are only allowed to possess them on their own property and in other limited instances such as at licensed shooting ranges or while hunting. Prohibited magazines have to be transported unloaded and locked separately from firearms and stored at home locked, making them unavailable for self-defense. Any violation of this measure is a gross misdemeanor punishable by a maximum of 364 days in jail and/or a fine of up to \$5,000.

On Tuesday, January 26, Senate Bill 5038 will be considered by the Senate Law and Justice Committee. As drafted, the bill makes it a crime to openly carry, on the person or in a vehicle, a firearm or other "weapon" if the person is participating in or attending a "demonstration" in a public place. "Demonstration" is loosely defined to mean any behavior by at least one person expressing views or airing grievances which is intended to or attracts an unspecified number of onlookers (a "crowd"). The bill also prohibits openly carrying a firearm or other weapon within 1,000 feet of a demonstration in a public place after a law enforcement officer advises the person to leave. The intent of the bill is called into question because a single person expressing their views on the sidewalk could be considered a "demonstration" under SB 5038. Senate Bill 5038 potentially causes those who are engaging in otherwise lawful activities to become criminals because of the actions of others.

### NSSF Reports ATF Drops Stabilizing Brace Objective Factors After Only 1 Week of Public Comment

The National Shooting Sports Foundation sent out an email late today December 23, 2020 announcing the Bureau of Alcohol Tobacco and Firearms (ATF) has rescinded its Notice of "Objective Factors for Classifying Weapons with Stabilizing Braces" that was published just last week in the federal register!

Yes just a week ago, ATF published a whole list of nonsense about how they should "Objectively" measure factors involved with Stabilizing or Wrist Braces which threatened to make over a million of those items illegal and any gun they are attached to would be classified in the same manner as a machine gun or suppressor under the National Firearms Act.

ATF made the required legal publication in the Federal Register and had to invite public comment for two weeks. There was a huge amount of outrage made public in the firearms media and with Pro Second Amendment groups. Apparently people did write in to make their objections known...and now the agency has rescinded the whole thing after only one week!

Well done all. Was it public outcry that caused it? Or political pressure? I don't know. I can't claim all the credit for them dropping it after I wrote my one email comment ...oh maybe I can...who knows at this point.

Perhaps they saw the logic of my written argument, or maybe your obvious common sense in print- I mean they already said these braces are legal...nah, it's the government, I think they got scalded in public trying to pull a fast one. They jumped the gun moving out on this issue before they had the new President elect and his gang for cover.

The good thing is, ATF has dropped the matter for now.
