Gun Control Group Hopes to Smear U.S. Firearms Industry with New Website

We all knew who the finger-pointers and tattletales were in junior high school. A disproportionate number of them,

it seems, now populate America's anti-gun lobby.

The off rebrended gun control organization gurrently calling itself Brady United Against Cun Violence (Brady)

The oft-rebranded gun control organization currently calling itself Brady United Against Gun Violence (Brady) launched a website this week called The Gun Store Transparency Project. This site is the result of Freedom of Information Act (FOIA) litigation Brady engaged in against the Bureau of Alcohol, Tobacco, Firearms and Explosives (ATF) to obtain certain ATF reports from inspections of Federal Firearm Licensees. Brady is now making those reports available to the public.

These reports, however, are not a random or representative sampling of ATF's inspection efforts but contain only those "in which the ATF issued an FFL a Warning Letter or more severe remedy"

In other words, the site completely ignores any inspection report -- which in 2020 comprised over 60% of them -- that did not result in findings of violations or sanctions.

Brady claims the purpose of the website is so "the American public will no longer be kept in the dark about businesses that contribute to gun violence in their communities, and whether federal authorities are failing to hold them accountable."

But is every business cataloged on the site "contributing to gun violence in their communities" simply because it was found, in some fashion, to be in non-compliance with the reams of federal laws and regulations that apply to licensed gun sellers? The answer, of course, is no.

There is no mystery to which sorts of violations will land an FFL in serious trouble with ATF. The agency publishes them on its own website: In addition to a refusal to allow an IOI to conduct an inspection, each of the following violations, absent extraordinary circumstances, will also result in ATF issuing a notice of revocation:

- Transferring a firearm to a prohibited person
- Failing to conduct a required background check
- Falsifying records

DONATIONS ACCEPTED

• Failing to respond to a trace request

These are the sorts of violations that pose the most obvious risk of a firearm falling into dangerous hands or that could impede law enforcement authorities from conducting a legitimate regulatory or criminal investigation.

None of these, however, appear on the ATF's list of the 10 "most frequently cited violations during ATF firearms inspections" in 2020. Instead, these "violations" are mostly the types of bookkeeping errors that are likely to occur in any context in which transactions are subject to a highly bureaucratic process that involves multiple ledger entries, forms, requirements for the production and recording of identification, and database inquiries.

Examples of the most common "violations," according to the ATF, include "[f]ailure to complete forms as prescribed" and missing signatures or dates.

Indeed, one of the reasons the National Instant Criminal Background Check System (NICS) itself doesn't always work as intended is because the millions of mostly government forms and computer entries on which it relies are themselves commonly incomplete, ambiguous, or simply erroneous.

This is why the ATF inspection process is not always or even usually a harshly punitive endeavor. Rather, it can also serve to help these heavily regulated businesses identity areas of operation or processes that need to be improved. The process, for example, includes a post-inspection conference so the FFL has an opportunity to respond to the alleged violations, initiate corrective actions, ask questions, and review relevant federal firearms laws and regulations with the inspectors.

This is also why the NRA supported the landmark Firearms Owners Protection Act in 1986, which ensured that the ATF inspection process could not be abused by anti-gun administrations simply to reduce the number of FFLs by any means possible.

To some degree, the process is similar to a student's report card, which can help with self-assessment and identify areas in need of improvement. But, just as academic report cards are not necessarily or usually about finding a pretext to kick the student out of school, ATF compliance inspections are not necessarily or usually aimed at shutting down the FFL.

There is no college degree specifically aimed at running a gun shop. FFLs are often small businesses that face the challenge not just of complying with federal law but the business, licensing, and zoning laws of states and localities as well. Some learning inevitably occurs on the job. It is hardly surprising that boxes sometimes get missed on forms, serial numbers get transposed, or someone forgets to make a copy of an identification document.

Fortunately, these scrivener type mistakes rarely have any material impact on public safety. That ATF usually recognizes this is laudatory and does not mean the agency is lax in holding industry members accountable.

As much as Brady may hate the idea, commerce in firearms is a legitimate, constitutionally protected business in the United States. There is nothing inherently shady or suspect about it, and members of the firearms industry should not be portrayed as criminals or public menaces for every mistake that winds up on a bureaucratic report. The inspectors themselves, after all, have to justify the work that they do and would risk total irrelevance and constantly diminishing resources if their labor didn't generate some sort of corrective action now and then.

Ironically, Brady's effort mostly underscores that FFLs operate within a heavily regulated environment and still mostly manage to do so safely, accurately, and with high levels of compliance.

It is true, as Brady asserts, that the ATF does not have the resources to inspect every single FFL right up to the legal limit. But the big picture that emerges from the ATF's own published data from inspections that do occur strongly indicates that would be a waste of time and resources, anyway.

NDAA Clears the U.S. Senate, Anti-Gun Provisions Left Out

Today, the U.S. Senate approved the National Defense Authorization Act (NDAA), the annual, bi-partisan legislation that directs funding for our nation's military and national security programs.

Thankfully for NRA Members and gun owners across the country, this legislation passed with two anti-gun provisions being struck from the final version. NDAA will now move to the President's desk to be signed into law.

As reported last week and following weeks of negotiations, the U.S. House of Representatives approved a revised version of the NDAA. The two anti-gun provisions that were included in an earlier version were removed from the final House-passed bill before being sent over to the U.S. Senate.

The first provision, led by Rep. Jackie Speier (D-CA), would have ignored constitutional due process protections and allowed for the confiscation of personally-owned firearms of members of the U.S. military. It would have afforded the military judicial system the ability to issue ex parte protective orders that would prohibit firearm possession without giving the accused an opportunity to contest the accusations against them and present evidence in their defense. This would have represented a clear denial of constitutional due process and a stunning betrayal of those who swore an oath to protect and defend our country and the U.S. Constitution.

The second provision, offered as an amendment by Rep. Norma Torres (D-CA), would have undone components of two export-reform regulations crafted by the Trump Administration. The regulations were designed to enhance American competitiveness, remove burdensome regulations for gunsmiths and other small businesses, modernize export controls, and enhance national security. Instead, the Torres amendment would have empowered anti-gun legislators to make decisions normally left to subject matter experts, leading to unnecessary delays and increased costs.

The efforts by anti-gun elected officials to include gun control in "must-pass" bills like NDAA is a good reminder that NRA members and Second Amendment supporters must remain vigilant against those who want to see our fundamental rights erased. NRA-ILA worked extensively with members of the U.S. House and Senate to have these provisions struck. "On behalf of our five million members, the National Rifle Association thanks House Armed Services Ranking Member Mike Rogers (R-AL) and Senate Armed Services Ranking Member Jim Inhofe (R-OK) for their tireless efforts to remove these provisions from NDAA," said NRA-ILA Executive Director, Jason Ouimet. "The due process and Second Amendment rights of our men and women in uniform should never be compromised."

It is a Good Day for Liberty.

I have just finished reading Gunfight by Ryan Busse. He was an early executive for Kimber and his account of the early days of the company is interesting. The rest of the book is a problem. An early objective of the Kimber leadership was that Kimbers would not be found at a crime scene. This is mostly because Kimbers are expensive. Criminals buy inexpensive guns because they frequently must discard them to avoid being caught. Extreme accuracy and reliability are not their major focus. The bulk of the book decries what he determines to be the "radicalization" of the gun community. He believes that gun companies sell guns through fear. Fear is involved but it is not the fault of the gun companies it is the fault of the news. People see crime and riots and threats to take our gun rights and they react. People hear threats to their rights, and they react. He complains that gun people react angrily. Of course, he does not mention the insults and threats hurled at us by the usual suspects. Our people are provoked and react accordingly. We should realize that the usual suspects are trying to provoke us to make us look bad and we should refuse to play their game. He insists that there is no real threat to our rights. He is upset by the popularity of semi-automatic rifles. He pretends that they are a new development. Semi-automatic rifles and shotguns have been produced since 1905. Semi-automatic surplus military rifles, including M 1 carbines with 30 round magazines, have been available since WW II. He insists repeatedly that AR 15 rifles are the same as M-16 rifles. He must know that this is not true. He insists that gun people are racist, that our every argument has a racist hidden meaning. He says that guns were sold in great numbers during President Obama's administration because he was Black. The fact that he threatened our gun rights is dismissed. Of course, the sales skyrocketed during the Clinton administration and now the Biden administration and for the same reason—they threatened our rights. He thinks that when Smith & Wesson compromised with the Clinton administration on our rights that the resulting boycott was a massive conspiracy promoted by the NRA. Of course, it was not. It was a reaction by the grassroots. We are not stupid; we do not need someone to tell us what to do. He demands that we compromise by giving up ARs and polymer-framed guns. Many people have received ATF form letters regarding purchases from Diversified Machine. The form letter tells the customer that if he or she bought silencers or silencer parts they must contact the ATF within 30 days. We do not know what happens after that. Some have products from the company and used them for fuel filters or some other legal use. Others have destroyed or discarded them. At least one built a suppressor after getting permission to do so from the ATF. It seems that ATF is taking the customer's word from what he did with the product. The customers are on an ATF list. I do not have a solid idea of how to respond. Talk to a lawyer first.

Missouri has eight congressional districts. Two are considered safe democratic seats, St Louis and Jackson County; six are considered safe republican seats. The Missouri legislature has proposed a new map of these districts based on the 2020 census. Under this map the borders of the districts are largely unchanged. Two years ago, FN announced that it would no longer produce the High Power. A Turkish company and Springfield announced that it would produce clones of the High Power. They appear to have envisioned them as improvements. Now FN has announced its own improvement on the High Power. Meddling with a Browning design calls for caution before purchase. One commentator has a one year rule for new firearms. He waits a year before buying one to see if any defects appear. I like the High Power. It nestles in my hand as if taking up residency. This works towards accuracy. I have one that was mistreated by two different Chinese armies for half a century. The magazine did not feed all thirteen rounds but with a new magazine the gun performed flawlessly. I purchased an Argentine High Power. Again, the magazine did not function reliably but with a different magazine it performed flawlessly. Magazines are important parts of firearms and must be carefully selected and maintained.

I've read another article arguing that the Japanese Type 26 revolver is the worst military handgun ever issued; worse than the Russian Nagant. The argument rests on the fact that the Type 26 cylinder rotates freely unless the trigger is pulled. The Nagant cylinder also freely rotates unless the trigger is pulled. The Type 26 breaks open to reload while the Nagant must eject and reload one cartridge at a time like the Peacemaker. I think that this gives the edge to worst pistol to the Nagant. I do not know enough about their relative accuracy to factor in this critical element. I do not expect a spirited debate in the gun magazines, but I thought it necessary to state my opinion. Feel free to agree with me.



More Guns = More Self-Defense

Americans legally bought more than 18 million firearms last year, and they've been putting those purchases to good use.

On Sunday, December 12, at 1 p.m. on Sycamore Lane in Garden Grove, California, a man with a history of domestic violence and the subject of an active restraining order broke into the home of his ex-girlfriend and stabbed her current boyfriend several times in the chest. The boyfriend survived, but his assailant escaped and, for whatever reason, was never put behind bars.

Five days later, the man returned, kicking in the door and chasing the couple into a room upstairs. This time, though, they were armed with a handgun. The boyfriend fired several shots, more than one of which found home, and the assailant died at the scene.

If ever a man had it coming to him, it was this guy. And if ever a gun-grabbing Democrat should've been made to explain to a law-abiding couple why they had no right to possess the handgun that ultimately saved their lives, this would've been the time.

This story didn't make national news — stories like this never do — but the American people would be better off if encounters like these were widely publicized. Were it so, would-be victims would likely be emboldened by the prospect of vigorous self-defense, and would-be assailants would likely think twice before preying upon another person.

Self-defense is, after all, our first human right and our most fundamental civil liberty. And the Second Amendment to our Constitution is the guarantor of that God-given right.

To be sure, this story out of Garden Grove wasn't a one-off. Each month, The Daily Signal publishes an article highlighting some of the previous month's many news stories on defensive gun use nationwide — stories that the mainstream media has no interest in publishing. Stories like the one out of Bolivar, Tennessee, where an armed Domino's Pizza employee drew his own gun and fatally shot a would-be armed robber. Or this one out of North Philly, where a merchant put a stop to a spate of armed robberies targeting Latino-owned businesses by shooting and wounding a 20-year-old man who'd tried to rob his corner store. Or this one out of Cairo, Georgia, where an elderly woman was awakened in the middle of the night to find several armed intruders. When she confronted them, she was shot, but she returned fire with her own weapon, causing them to flee. Seven suspects were later arrested.

As The Daily Signal notes, "Americans legally bought more than 18.5 million firearms in 2021, down just slightly from 2020's unprecedented surge in gun sales but still the second-highest year for sales on record." And, as indicated in the stories above, the American people are using them for self-defense — somewhere between 500,000 and three million times annually, according to a 2013 CDC report.

The Signal's parent organization, The Heritage Foundation, has been keeping an interactive database of defensive gun use since 2019. As of today, it's documented 2,061 such instances of self-defense.

As you've no doubt noticed by now, we have a serious crime problem in our country — a problem that the Left reflexively blames on guns. This, of course, is a lie. As our Mark Alexander has noted time and again, crime is a Democrat-induced *culture* problem, not a gun problem. "Criminals commit crimes," he writes, "and until Democrats reverse course on the social policies that have devastated American families and communities for decades, the consequential violence will continue."

In the meantime, we can be thankful for our Second Amendment, which ensures our first human right.


