

Emergency Risk Protection Orders (Ref Flag Laws)

What is the NRA's position on emergency risk protection orders (ERPOs)?

The NRA's position on emergency risk protection orders (ERPOs) has recently been mischaracterized by some who haven't taken the time to understand our position, including the anti-gun mainstream media and organizations that purport to support the Second Amendment. Many of the individuals mischaracterizing our position are using misinformation to simply attack the NRA.

The NRA fights for the constitutional freedoms, including the due process rights, of all law-abiding Americans, every day in Congress, the statehouses and the courts. Our record on this is clear. Due process of law is a bedrock of our constitutional freedoms. Without it, we would cease to exist as a free country.

All fifty states currently have civil commitment procedures and many lack basic due process protections. This is unacceptable. The NRA believes that no one should be deprived of a fundamental right without due process of law.

Some have raised the issue of current ERPO laws in California, Oregon, Vermont and other states, suggesting that the NRA supports those laws. This is false. The NRA strongly opposed these laws because they do not protect due process rights. We will continue to oppose confiscation schemes such as these.

In addition, the NRA opposes any effort to create a federal ERPO law, in which federal agents would be tasked with seizing firearms after a hearing in federal court. As states consider ERPO laws, the NRA will continue to push for the inclusion of strong due process protections.

The NRA believes that any effort should be structured to fully protect the Second Amendment rights of law-abiding citizens while preventing truly dangerous individuals from accessing firearms.

The requirements of an ERPO process that the NRA could support should include the following:

- The process should include criminal penalties for those who bring false or frivolous charges.
- An order should only be granted when a judge makes the determination, by clear and convincing evidence, that the person poses a significant risk of danger to themselves or others.
- The process should require the judge to make a determination of whether the person meets the state standard for involuntary commitment. Where the standard for involuntary commitment is met, this should be the course of action taken.
- If an ERPO is granted, the person should receive community-based mental health treatment as a condition of the ERPO.
- Any ex parte proceeding should include admitting the individual for treatment.
- A person's Second Amendment rights should only be temporarily deprived after a hearing before a judge, in which the person has notice of the hearing and is given an opportunity to offer evidence on his or her behalf.
- There should be a mechanism in place for the return of firearms upon termination of an ERPO, when a person is ordered to relinquish their firearms as a condition of the order.
- The ERPO process should allow an individual to challenge or terminate the order, with full due process protections in place.
- The process should allow firearms to be retained by law-abiding third parties, local law enforcement, or a federally licensed firearms dealer when an individual is ordered to relinquish such firearms as a condition of the ERPO. The individual must also have the ability to sell his or her firearms in a reasonable time without violating the order.

Again, the NRA will continue to oppose any proposal that does not fully protect due process rights. We will only support an ERPO process that strongly protects both Second Amendment rights and due process rights at the same time.

Last month erroneous information about the NRA's position was published in this newsletter. We have since learned that, as shown above, the NRA DOES NOT support any of the existing "Red Flag" laws either enacted or proposed.

**LIBERTY NOTES***By Kevin L. Jamison*

It is a good day for Liberty.

RALLY DAY will be 16 April, 2019 in the Rotunda of the Capital Building in Jefferson City from 10 AM to noon. This is the day after tax day which makes it easy to remember. A speaker is being searched for, possibly drafted and quite possibly kidnapped.

A letter to the local tabloid complains that the individual rights interpretation of the Second Amendment by the Supreme Court was not the original interpretation. This is nonsense. When the Bill of Rights was first presented to the public the Second Amendment was described as protecting the individual's right to possess his private arms. There were repeating firearms long before the Constitutional period. Of more importance is that the Supreme Court has repeatedly ruled that the Constitution protects rights, not technology. The Second Amendment protects semi-automatic firearms as well as muskets in the same way the Fourth Amendment protects the privacy of cell phones as well as letters written with quill pens.

Mona Oliver has investigated the Capital Building's rule on concealed carry. Persons with a license to carry need to show their license and photo ID at the entrance. These persons can carry concealed in most places except for the floor of the house and senate, galleries, hearing rooms and certain legislators may have posted their offices. The halls and rotunda are legal to carry concealed if one has a license to carry. This does not count for permitless carry. A license to carry will also get you past the metal detector.

I saw a magazine article about an unusual new pistol--now I can't find the magazine. This pistol has the slide and barrel set back in the frame. The theory is that in extreme close quarter combat the pistol might be thrust into the attacker. In most modern semi-automatic pistols this would put the slide out of battery and it would not fire. In one model of this pistol the forward part of the frame is cut into teeth. If this pistol is thrust into the attacker, it will not only fire it will collect the attacker's DNA. This is a good idea. I still like my CZ 75--it has a bayonet.

A "study" claims that states with strict gun control have higher homicides when they border states with "lax" controls. It says criminals cross to the "lax" states to buy guns. Does not explain why "lax" states do not have the homicide rate of the strict states. It is illegal for persons to buy guns across state lines. It is completely illegal for handguns. It is legal to buy long guns across state lines only if both states allow it.

There was a hearing in Jefferson City on reducing the number of "gun free" zones. Our side was outnumbered 3 to 1 by the usual suspects. We need to make a better showing at Rally Day.

A woman born in Alabama moved to Syria and joined Isis when she was 19. She married a succession of ISIS fighters--they kept getting killed. She used social media to encourage the murder of Americans. Now ISIS has lost the war and she wants to come back. She has committed treason but says she would rather be in prison in America than a refugee camp in Syria. This lady's decision making has been questionable in the past. The administration has taken the position that she is not an American citizen because her father was a diplomat. Birth citizenship does not apply if the parents are here as diplomats. It seems that the father was not a diplomat at the time of her birth. He was a diplomat during the critical conception event. I have not heard about the citizenship of the mother who would seem to be relevant. If the woman is not a citizen she is not coming back. If she is not a citizen, she did not commit treason.

Hawaii's legislature has passed a resolution to repeal the Second Amendment. Hawaii is not alone in this.

A Virginia man was convicted of murder. He had repeatedly told a man not to come around his home. When the man broke through a dead-bolted front door he killed the man. This was enough for conviction. The dead man's brother rented a room in the homeowner's house and this may have inspired the unwanted visitations. The conviction was overturned by the Virginia court of appeals in a 7-4 decision. This demonstrates that what is obvious to us is not obvious to the oblivious.

We have all heard people complain about the attacks on our rights. Give them a membership application. If they are not doing something, they have no right to complain.

A bill was introduced in congress to treat muzzle loading guns the same way as modern firearms. So, buying a replica of the flintlock musket my ancestor used at Concord Bridge that day in April 1775 would require filling out a 4473 and getting clearance through NICS. People prohibited from owning firearms will no longer be able to possess and hunt with muzzle loaders. There has been no mass use of muzzle loaders in crime. The usual suspects simply cannot let something go unregulated. I know, this bill is unlikely to become law; at this time. It shows us how the opposition is thinking. There will be another election in a year and a half.

It is very strongly suggested that former Vice-President Joe Biden will run for president in 2020. He is what passes for a moderate in the Democratic Party these days; except on our issue. On our issue he is extreme as they come. He famously advised firing both barrels of a double-barrel shotgun as a warning shot at perceived prowlers. People who have taken his advice have gone to jail.

A divided Connecticut Supreme Court has ruled that Remington can be sued for the Sandy Creek school massacre. Remington made the AR used in the murders. The court found that Remington was protected under the federal Protection of Lawful Commerce in Arms Act. It allowed the suit to go forward under a wrongful marketing claim. This allows the usual suspects to continue to go fishing through Remington records looking for wrongdoing. Remington must go to the expense of providing this information. It would seem to me that marketing is included in "commerce."

The Ninth Circuit Protects Gun Rights and Stops Confiscation

Every now and then the Ninth Circuit Court of Appeals — arguably the nation's most progressive federal circuit — can offer up a legal surprise. Yesterday, it gave us a legal shock, when a divided panel of its judges affirmed last year's federal district court injunction temporarily blocking enforcement of California's confiscatory ban on so-called large-capacity magazines.

Under California law, any person who possesses a legally purchased magazine capable of holding more than ten rounds of ammunition must either remove the magazine from the state, sell it to a licensed firearm dealer, or hand it over to law enforcement. Those citizens who retained their magazines after the law went into effect risked a fine or up to one year's imprisonment in county jail.

The district court's 66-page opinion was a legal tour-de-force that not only dismantled California's justifications for the ban, but also reiterated and reinforced the constitutional and historical basis for the right to keep and bear arms

SMITH & WESSON CLOSING MASSACHUSETTS WAREHOUSE, MOVING TO MISSOURI

American Outdoor Brands Corp., the parent company of gun maker Smith & Wesson, has announced they are closing their New England warehouse operation.

The publicly-traded company will be moving their distribution center to a new facility in Columbia, Missouri later this year. The news came as AOBC announced their financial results for the third quarter which overall saw sales increase by about 3 percent in the wake of announcing more than 250 new products from across the corporation's varied divisions.

"The ramp-up of initial operations at our new Logistics & Customer Services facility in Missouri is well underway and on track," said James Debney, AOBC's CEO. "This 633,000 square foot, state-of-the-art facility will serve as our centralized logistics, warehousing, and distribution operation for all of our products, facilitating our growth, enhancing our efficiencies, and allowing us to better serve customers across our entire organization."

The Boston Business Journal reports the current Springfield, Massachusetts-based logistics warehouse, as well as one in Jacksonville, Florida, will close, with their operations folded into the Missouri center, which will hire 154 new workers. The Columbia facility has been in the works since 2017 with a combination of offsetting local tax breaks.

Then-Missouri Gov. Eric Greitens welcomed the company with open arms to the Show Me State two years ago, saying, "Missouri has always been a great Second Amendment state, a wonderful state, for people who love firearms and treasure their Second Amendment rights."

Meanwhile, in Massachusetts, anti-gun protestors joined by at least one state Democratic gubernatorial candidate, have repeatedly picketed Smith & Wesson's historic factory. The iconic company will continue to make guns in the state. According to data from federal regulators, Smith manufactured 1.4 million pistols, 396,710 rifles, and 294,680 revolvers as well as a smaller number of miscellaneous firearms and shotguns in Springfield in 2016, the most recent year for which figures are available.
