

### Mainstream Media Lies to Cover for Kamala

The legacy media has mostly given up the pretense of carrying out its once-professed mission – holding power to account. At this point, no reasonable person expects the regime press to cover legitimate news that might reflect poorly on their political allies. Still, conspicuous ignorance is one thing, distortion is another.

At an August 3 campaign rally in Atlanta, President Donald Trump told those gathered that Vice President Kamala Harris “supports mandatory gun confiscation.” On August 7, the ill-named PolitiFact rated Trump’s statement “mostly false.” As NRA-ILA has regularly documented, Trump is correct. Harris has repeatedly supported prohibiting and confiscating commonly-owned semi-automatic firearms, including America’s most popular rifle – the AR-15.

At a 2020 presidential campaign event in Londonderry, N.H. in September 2019, then-presidential candidate Harris told reporters that confiscation of commonly-owned semi-automatic firearms was “a good idea.” Elaborating on her support for a compulsory “buyback” program, the senator added, “We have to work out the details – there are a lot of details – but I do...We have to take those guns off the streets.”

On the September 16, 2019 episode of “The Tonight Show Starring Jimmy Fallon,” Harris reiterated her support for gun confiscation. During a question-and-answer session, an audience member asked Harris “Do you believe in the mandatory buyback of quote-unquote assault weapons and whether or not you do, how does that idea not go against fundamentally the Second Amendment?”

The candidate responded, “I do believe that we need to do buybacks.” Making clear that she believes Americans’ Second Amendment rights are for sale, Harris added “A buyback program is a good idea. Now we need to do it the right way. And part of that has to be, you know, buy back and give people their value, the financial value.”

Further demonstrating Harris’s commitment to gun confiscation, the candidate called for a “mandatory buyback program” during an October 3, 2019 MSNBC gun control forum and again during a November 2019 interview with NBC Nightly News.

Given Harris’s obvious and indisputable record of support for gun confiscation, a reasonable person might wonder how a news outlet could rebut Trump’s accurate statement. PolitiFact’s lazy reasoning boiled down to: That was then, this is now. And PolitiFact’s sole piece of “evidence” for their conclusion? Less than a sentence from a New York Times article that cited Harris “campaign officials.”

So, Americans can either believe the actual presidential candidate’s repeated calls for gun confiscation in her own words on video or a second-hand account of what a campaign official supposedly said to a regime press outlet about a purported flip-flop on an unpopular policy. Are Americans supposed to believe so-called “factcheckers” are this gullible, or is there something else at play? There is a reason statements against interest are given special weight in court.

Moreover, while PolitiFact may want to portray 2019 as ancient history, there’s more recent evidence that Harris supports gun confiscation. Noticeably absent from the PolitiFact piece was any mention of Harris’s October 26, 2023 remarks at a state luncheon with Australia Prime Minister Anthony Albanese. Harris praised Australia’s gun control measures – the most famous of which was the Aussie equivalent of Harris’s gun confiscation proposal. Referencing violence perpetrated with firearms, Harris remarked, “And let us be clear, it does not have to be this way, as our friends in Australia have demonstrated.” (emphasis added).

In 1996, Australia adopted a near total ban on civilian ownership of semi-automatic rifles and semi-automatic and pump-action shotguns. To coincide with the new restrictions, the government instituted a mandatory “buyback” confiscation scheme where gun owners were required to turn their newly-prohibited firearms over to the government for a set price.

Thankfully, fewer and fewer Americans are relying on the regime press to mediate reality. In October, Gallup reported the results of a recent poll, stating,

The 32% of Americans who say they trust the mass media “a great deal” or “a fair amount” to report the news in a full, fair and accurate way ties Gallup’s lowest historical reading, previously recorded in 2016.

Another 29% of U.S. adults have “not very much” trust, while a record-high 39% register “none at all.”

On June 26, the Washington Post published a piece titled “A new measure of Americans’ deep distrust of the media.” The item explained,

Americans simply don’t trust the media, particularly when it comes to politics. Swing-state polling from The Washington Post and the Schar School of Policy and Government at George Mason University found that only 3 in 10 residents of six of the most important states in this year’s presidential election trust that the media will fairly and accurately report political news. Seven in 10 indicated that they had not too much trust in that occurring – or that they had no trust at all.

The notion that the legacy press is unbiased is quite literally laughable. A visible manifestation of this sentiment occurred on the August 12 episode of “The Late Show with Stephen Colbert.” Audience members burst into laughter when the host, in all seriousness, suggested that CNN is objective.

With the regime press losing all semblance of credibility, NRA members and other gun rights activists should work even harder to share the facts about about the dangers Harris poses to the Second Amendment and gun ownership with their family, friends, neighbors, and other freedom-minded individuals.

### FED. JUDGE RULES LICENSED CARRY BAN ON IL PUBLIC TRANSIT UNCONSTITUTIONAL

A federal district court judge in Illinois has ruled that state’s ban on licensed concealed carry aboard public transit violates the Second Amendment in a case supported by the Second Amendment Foundation (SAF). The case is known as *Schoenthal v. Raoul*.

In a 50-page decision, U.S. District Judge Iain D. Johnston, a Donald Trump appointee in the Northern District of Illinois, Western Division, granted declaratory relief to the four plaintiffs—Benjamin Schoenthal, Mark Wroblewski, Joseph Vesel and Douglas Winston — who brought their lawsuit in an effort to carry concealed firearms on Metra and on Metra’s real property. In addition, Vesel and Winston also secured relief for riding on CTA (Chicago Transit Authority) and being on CTA property.

SAF was joined by the Firearms Policy Coalition in financially supporting the plaintiffs. Plaintiffs are represented by attorney David Sigale of Wheaton, Ill.

Defendants are Illinois Attorney General Kwame Raoul and State’s Attorneys Rick Amato (DeKalb County), Robert Berlin (DuPage County), Kimberly M. Foxx (Cook County) and Eric Rinehart (Lake County), all in their official capacities. In his ruling, the judge dismissed claims against Amato and Rinehart. The ruling applies to Raoul, Foxx and Berlin as it applies to Schoenthal. The ruling applies to Raoul and Foxx as it applies to Wroblewski, Vesel and Winston.

“This is a significant victory for legally armed Illinois residents who rely on public transit,” said SAF founder and Executive Vice President Alan M. Gottlieb. “It is important that the court recognized Cook County Attorney Foxx’s argument that the ban was legal because Illinois is acting as a property owner was ‘breathtaking, jaw dropping and eyepopping,’ and that wasn’t a compliment. It demonstrates how far government will reach in an attempt to justify its effort to restrict Second Amendment rights.”

“This is one more step in SAF’s mission to win firearms freedom, one lawsuit at a time,” added SAF Executive Director Adam Kraut. “Illinois was attempting to perpetuate an indefensible policy of public disarmament, and Judge Johnston’s ruling brings that to a halt.”

### New Hampshire Attorney General Challenges Massachusetts’ Gun Laws

New Hampshire Attorney General John Formella said Monday that Massachusetts should not have the right to prosecute residents who cross state lines with their guns, WBZ reported.

In briefs filed with the Massachusetts Supreme Judicial Court, Formella defended two New Hampshire men who were charged with unlawfully carrying weapons into Massachusetts without the proper firearms license, according to WBZ.

Formella said in a statement that his challenge was directed at “Massachusetts’ restrictive firearms laws,” and “we are affirming that constitutional freedoms should not be undermined by inconsistent and overly burdensome regulations.”

Formella added, “This is all about ensuring that responsible gun owners can protect themselves without fear of unjust legal consequences when they cross state borders.”

A Lowell District Court judge had previously ruled that those legally entitled to carry guns in their home state can’t be prosecuted in Massachusetts for illegally carrying guns, according to the outlet.

“Massachusetts, like many states, deals with significant and substantial crime in its communities,” Formella’s filing said. “Accordingly, it is illogical to think that the moment a New Hampshire citizen crosses the border into Massachusetts that he or she is stripped of his or her constitutionally protected right to self-defense.”

In his arguments, Formella referenced the Pheasant Lane Mall, which sits directly on the state border, WBZ reported. Since the border runs directly through the mall’s parking lot, Formella stated, “Surely the Second Amendment’s protection of a person’s right to carry a firearm for self-defense is not so fragile as to allow Massachusetts to compel a New Hampshire citizen to choose between exercising his or her right to self-defense and visiting the Buffalo Wild Wings at the Pheasant Lane Mall.”

Middlesex County District Attorney Marian Ryan defended her state’s prosecution of the two New Hampshire men, stating that they were treated “exactly the same as Massachusetts residents” under the law, WBZ reported.

“Nothing in the Constitution prohibits Massachusetts law enforcement officers from enforcing state law within its own borders,” Massachusetts Attorney General Andrea Campbell said, according to WBZ.

The Supreme Judicial Court of Massachusetts will hear the case Sept. 9, the outlet reported.



## LIBERTY NOTES

It is a good day for Liberty.

I've listened to an audio-book "The Death of Caesar" by Barry Strauss. I am informed that Caesar was lured to the Roman Senate by the conspirator because weapons were forbidden there. A prohibition the assassins intended to ignore. In over 2,000 years we have not learned. Caesar was enthusiastically stabbed with "assault daggers;" Roman military daggers.

I have listened to "The American Revolution" part of the Great Courses lectures. It seems that after the Battle of Lexington and Concord British wounded were left on the field. They were cared for by local people. Some of these wounded declined to rejoin their regiments—they had married local women. Thus we are shown another way to take an enemy soldier off the field.

Blood banks are critically low on blood. My brother had leukemia. Every so often he was given a blood transfusion and it made him a new man. Then there are the slings and arrows of outrageous fortune, traffic accidents and drunken buffoons. Wear a gun-related button, shirt or cap or read a gun magazine during the process. It shows people we are the good guys. It costs nothing to donate and afterwards you get a cookie. How bad can that be?

I had a client from the Middle East. He LOVES this country. His daughters can wear a headscarf or not wear a headscarf and no one threatens to kill him over the issue. Our ancestors created something wonderful here, not perfect, but wonderful. We must ensure that we keep it for our grandchildren.

I've read "Blood on the Leaves" written by a trio of game wardens. We often forget that game wardens are law-enforcement officers. They investigate poaching, which interferes with prospects for our own hunting, and "hunting accidents." I put accidents in quotes because with 70 years of experience between them they saw exactly two true accidents. The rest were negligent, reckless and even criminal use of firearms. Everyone wardens encounter is armed. The first chapter is titled, "The First Time I Got Shot." A later chapter is titled, "The Last Time I Got Shot." Unlike most crime books guns, ammunition and ballistics are discussed in detail. This is the best explanation of shootings I have seen outside of a forensic textbook. The authors complain that people killed while hunting are summarily put down to "accidents." Their investigations frequently found evidence of manslaughter at least. They cynically advise that if you want to murder someone, taking him hunting. The death will be put down as an accident and not investigated. The book should be read by hunting safety instructors and people who need a warning that they going into the woods filled with idiots, drunks, the negligent, the reckless; and people with a dim idea of the safety rules, the safety on their gun or the kitchen table gunsmith who modified the gun to speak when it was not spoken to.

There was an incident at the NRA's Whittington Center. One of the officers was examining guns that had been donated. He dropped the magazine from a handgun, which struck a .22 Walther, which fired shooting the officer through the hand. The NRA described this as a negligent discharge. I would call it, more charitably, a freak accident. It does stress the need for caution when handling firearms. The Walther appears to have been shipped loaded which is not legal and should not happen.

Hilary Clinton has declared that people should be fined and criminally charged for spreading "disinformation." She gets to decide what is "disinformation." She remains a powerful voice on the left. That should send you all running to the voting booth.
